FireMaster Duplex Horizontal Active Fire Curtain

- This certification is provided to the client for their own purposes and we cannot opine on whether it will be accepted by Building Control authorities or any other third parties for any purpose.
- 2. This approval relates to the use of the Firemaster Duplex Horizontal Active Fire Curtain in providing a fire resistance performance of up to 120 minutes integrity performance, were it subject to test using the general principles of BS EN 1634-1:2014 + A1:2018, for exposure from below. The scope of approval is summarised as follows:

Continuous Barrier / Single Roller

All dimensions quoted in the above table are the outer dimensions of the entire construction (including head boxes and side guides).

It shall be noted that the maximum possible length and width measurements, quoted in the '60 or 120' row of the above table, are each subject to a maximum total area of 49m².

It shall be noted that the maximum possible length and width measurements, quoted in the '60' row of the above table, are each subject to a maximum total area of 60m². i.e. only a 20m long by 3m wide curtain will use the full 60m² maximum area.

- 3. The product is CERTIFIRE approved on the basis of:
 - i) Initial type testing.
 - ii) An appraisal against TS30.
 - iii) Inspection and surveillance of factory production control.
 - iv) Audit testing at a frequency as defined in TS30.
- 4. The approval relates to on-going production. Product and/or its immediate packaging is identified with the manufacturer's name, the product name or number, the CERTIFIRE name or name and mark, together with the CERTIFIRE certificate number and application where appropriate.
- The FireMaster Duplex Horizontal Active Fire Curtains are approved for installation into apertures in concrete or masonry flooring having a fire performance no less than that required for the fire curtain. Typical installation details are provided in the datasheet.
